



## 2025 Fees and Levies

The Tuition Fees and Levies charged at Caloundra City Private School fall into 4 categories;

- **Tuition Fee and Resource Levy:** For a student at CCPS, the Tuition Fee covers most education costs. It includes tuition costs, school diaries, library resources, ID cards, locker keys, year book and all subject and classroom resources.
- **Technology Levy:** A Technology levy is charged from Year 4 to Year 12 to support the investment in IT resources. Years 4, 5 and 6 bring their own iPad while Years 7 – 12 participate in the School's Computer Program which includes a fully programmed contemporary computer which is replaced every 3 years. Year 12 students retain their computer upon graduation at no extra charge.
- **Compulsory Camps and Excursions:** A fixed amount is charged for compulsory camps, excursions and activities. This is charged at the commencement of the school year. Costs may vary depending on the activities undertaken.
- **Building Fund:** The Building Fund Levy is used to fund the construction of buildings and other educational facilities which are essential to enabling the provisions of quality education. A non-compulsory Building Fund contribution is added to each account.

## Sibling Discount

CCPS offers sibling discounts to families with more than one child attending from Prep. Sibling discounts are applied to the tuition fee at the rate of 10% reduced tuition fee for the second child and 25% reduced tuition fee for the third child and 50% reduced tuition fee for the fourth child. For the fifth and subsequent child there is no Tuition Fee charged.

## Family Loyalty Discount

CCPS is committed to supporting our long-term families. Students who commence in the Junior school and complete Year 5, Year 6 and Year 7 and re-enrol for the next year receive a refund of their confirmation fee at a rate of \$250 per year.

## Payment Options

School Fees are invoiced per term and are due on the first Friday of the Term (Year 12 students have three billings only). Accounts can be paid via the following: -

- Bpay: See front of fee statement for your Biller Code and reference number.

## Withdrawal of a Student from the School

- Should parents wish to terminate their child's enrolment prior to completion of schooling to Year 12, then written notice must be received by the school by no later than five (5) weeks before the end of the term of which it is intended, they should leave.

## Students who are new to CCPS

- Prior to the commencement at CCPS parents will be required to pay 25% of the school fee account for Term 1 and this will be via a credit card payment automatically deducted by the school in the last week of November of the year before they start.
- New families who commence during the school year will be required to pay the full Terms Fees as per due date or within 2 weeks of commencing.

## Building Fund

There is a voluntary building fund contribution of \$200 per term per student or \$800 per annum.

## GST

Where possible the School will quote its tuition fees and charges on a GST inclusive basis. If GST becomes payable in respect of any part of any tuition fee and charges levied by the School then the School reserves the right to increase these tuition fees and charges at any time.
